Environmental Policy Statements

Policy Aims

We also favor suppliers who strive to improve their environmental performance, provide environmentally preferable products, and who can document the supply chain impacts of their efforts.

We endeavor to:

- Comply with all relevant regulatory requirements.
- Continually improve and monitor environmental performance.
- Continually improve and reduce environment impacts.
- Incorporate environmental factors into business decisions.
- Increase employee awareness and training.

Paper

We will:

- Minimize the use of paper in the office.
- Reduce packaging as much as possible.
- Seek to buy recycle and recyclable paper products.
- Reuse and recycle all paper where possible.

Energy and Water

We will:

- Reduce the amount of energy used as much as possible.
- Switch off electrical requirements when not in use.
- Rake energy consumption and efficient of new products into accounts when purchasing them.
- For all battery powered MEWPs, we make sure they are not left in charge for longer than needed.

Transportation

We will:

- Reduce the need to travel, restricting to necessary trips only.
- Promote the use of travel alternatives such as e-mail or video/phone conversation for site visits.
- Make additional efforts to accommodate the needs of those using public transport or other friendly modes of transport.

Maintenance and cleaning

We will:

- Maximizes post-consumer recycled content.

- Are made from sustainably produced materials.
- Are compostable or biodegradable.

Culture


We will
